In continuation of this Ministry's letter of even number dated 19.3.2013 & 02.4.2013, I am directed to convey the approval of the Central Government to renew the permission for 3rd year MDS course in the specialities of (i) Oral & Maxillofacial Surgery with 3 seats (ii) Paedodontics and Preventive Dentistry with 3 seats (iii) Conservative Dentistry and Endodontics with 3 seats (iv) Prosthodontics and Crown & Bridge with 3 seats (v) Periodontology with 3 seats (vi) Orthodontics & Dentofacial Orthopedics with 3 seats (vii) Oral Pathology & Microbiology with 3 seats and for 2nd year MDS course in the specialities of (i) Oral Medicine & Radiology with 3 seats (ii) Public Health Dentistry with 3 seats at Surendra Dental College & Research Institute, Sri Ganganagar for the academic year 2014-15.

2. The admission of next batch of students in MDS Course in the above specialities for the academic year 2015-16 will be made only after recognition/renewal permission by the Central Government.
3. In case any admissions are made in violation of this condition, such admissions would be treated as irregular and action under 10B of the Dentists (Amendment) Act, 1993 would be initiated.
4. Discrepancies, if any, may be brought to the Notice of DCI and State / Central Government.


